Rules & Payoff

1. Futurity is open to horses foaled in 2004 or after. Horses must not reach the age of 6 in 2009.
2. To be eligible for the futurity, the horse must have never competed in
3. ANY barrel race prior to December 1st, 2008. To do so means forfeit of any and all fees paid and elimination from the futurity. Horses may have competed anywhere after 12/1/08.
4. Owner and or rider may enter on more than one horse. Owner does not have to ride their own horse, but a rider **MUST** be designated on entry.
5. Registration papers or vet affidavit for age of horse must accompany a Entry copy of
6. Down barrel is a 5 second penalty and will carry over to 4D as a no time.
7. Reruns given **ONLY** if eye fails to work. Penalties are not carried over.
8. Tractor drag every 5 in both futurity & Open 4D.
9. Total Futurity Entry Fees will be \$150. Includes a \$45 office & processing fee.
Division of purse will be:
1D 70% 2D 30%.
1D - 30% to Go-Round. 40% to Fastest Average
2D - 50% to Go-Round only. Full Second split.
1st Go-Round will be drawn and reversed for 2nd Go-Round
9. Purse will be \$500 Added plus \$105 from all fully paid up horses.
10. Absolutely no barrels in arena before timed runs or after barrel race.
11. Where this is our first year and a late start at that, there will be no dress code & no late payment fee for the May 27th payment .
12. F Bar has the right to refuse entry to any horse or individual
